FIRE DEPARTMENT MONTHLY REPORT

May 2015

This month's activities resulted in Station 36 responding to **70** calls for service; **49** incidents were for emergency medical and **21** incidents were suppression-related. Station 36 responded to **37** calls within our section of the Village of Inverness and **7** calls in the other side of Inverness. The District logged **10** calls within the Southeast Area and **16** incidents in all other contract areas for an overall total of **96** calls.

05/15/15 15-00373 150 S. Oak VOP Structure Fire

A36 responded to the reported house fire. A36 treated two patients (1-ALS and 1-BLS) and transported cold to SAMC.

05/18/15 15-00384 2 Wind Ridge South Barrington, Structure Fire

TND 36 responded for the structure fire. Members worked on hand line, setup their porta tank, and setup a water supply fill site.

A Chief was due on the MABAS 2nd Alarm. 701 responded and assisted with operations on scene.

05/21/15 15-00391 754 East Glencoe. VOP, Structure Fire

Ambulance 36 responded into Palatine for a basement fire in a private dwelling. A-36 arrived on scene and reported to the Command Post. Crew was released from Command Post after fire was extinguished.

05/29/15 15-00411 763 Prarie. Barrington Structure Fire

E36 Responded mutual aid to Barrington for a report of a house fire. E36 arrived as second engine and deployed a hand line into the front door. The fire was in outside walls of the structure near the front door. Hand tools were used to open walls and extinguish a fire apparently started by plumbers sweating a pipe in that location.
