FIRE DEPARTMENT MONTHLY REPORT

January 2016

This month's activities resulted in Station 36 responding to 67 calls for service; 32 incidents were for emergency medical and 35 incidents were suppression-related. Station 36 responded to 28 calls within our section of the Village of Inverness and 5 calls in the other side of Inverness. The District logged 4 calls within the Southeast Area and 12 incidents in all other contract areas for an overall total of 83 calls.

On this evening at approximately 11:30 PM, an elderly man came to the firehouse asking for directions to Rockford. After talking to the gentlemen briefly, FFs Pete Retuerto and Chris Annoreno discovered that the gentleman had been driving around the entire day, essentially lost. He had left home early in the day to take his wife for medical treatment. Our firefighters recognized the severity of the situation and were able to obtain more information from the gentlemen. With this additional information and the assistance of the Inverness Police, they were able to contact the medical treatment center and obtain family contact information. The couple's daughter, who lives locally, was reached by phone. The daughter had been looking for her parents all day and soon arrived to take them home.

Fortunately our firefighters recognized that this couple needed help, much more than just directions home.

Both Pete Retuerto and Chris Annoreno have been commended for their compassion and professionalism.
