FIRE DEPARTMENT MONTHLY REPORT

March 2016

This month's activities resulted in Station 36 responding to **69** calls for service; **40** incidents were for emergency medical and **29** incidents were suppression-related. Station 36 responded to **26** calls within our section of the Village of Inverness and **10** calls in the other side of Inverness. The District logged **2** calls within the Southeast Area and **19** incidents in all other contract areas for an overall total of **90** calls.
