## **FIRE DEPARTMENT MONTHLY REPORT**

### **April 2018**

This month's activities resulted in Station 36 responding to **84** calls for service; **55** incidents were for emergency medical and **29** incidents were suppression-related. **21** Of the medical calls were BLS while **29** were ALS and **5** didn't require medical care. Station 36 responded to **33** calls within our section of the Village of Inverness and **5** calls in the other side of Inverness. The District logged **9** calls within the Southeast Area and **10** incidents in all other contract areas for an overall total of **103** calls.
