FIRE DEPARTMENT MONTHLY REPORT

December 2015

This month's activities resulted in Station 36 responding to **69** calls for service; **44** incidents were for emergency medical and **25** incidents were suppression-related. Station 36 responded to **31** calls within our section of the Village of Inverness and **6** calls in the other side of Inverness. The District logged **10** calls within the Southeast Area and **6** incidents in all other contract areas for an overall total of **85** calls.

12/10/15 #15-0966 1580 North St. VOP - Structure Fire

District 36 units responded into Palatine on a report of a structure fire. Both units were assigned to the interior first floor and basement to search for hidden fire.

12/11/15 #15-0972 940 Maywood Lane Hoffman Estates – Structure Fire

A36 responded on the code 4 into Hoffman Estates - They were assigned rehab.

12/18/15 #15-0987 2085 Frost Rd. Schaumburg Township - Structure Fire

District 36 responded to a house fire at 2085 Frost. The building was well involved in fire upon arrival. A large diameter (2 ½) hand line was deployed and the fire extinguished. A search revealed a German shepherd dog that was inside the building during the fire. The dog was removed and administered oxygen and the fully recovered.
