FIRE DEPARTMENT MONTHLY REPORT

October 2014

This month's activities resulted in Station 36 responding to **81** calls for service; **48** incidents were for emergency medical and **33** incidents were suppression-related. Station 36 responded to **32** calls within the Village of Inverness, with **7** responding to Barrington Countryside. The District logged **11** calls within the Southeast Area and **8** incidents in all other contract areas for an overall total of **100** calls.
