## FIRE DEPARTMENT MONTHLY REPORT

### January 2017

This month's activities resulted in Station 36 responding to **105** calls for service; **71** incidents were for emergency medical and **34** incidents were suppression-related. Station 36 responded to **46** calls within our section of the Village of Inverness and **16** calls in the other side of Inverness. The District logged **7** calls within the Southeast Area and **11** incidents in all other contract areas for an overall total of **123** calls.

#### Calls of Interest:

- January 27 A36 responded into Hoffman Estates on reported structure fire. A36 was assigned to search first floor.
- January 29 E 36 responded into Barrington for a structure fire. E36 was assigned various tasks to facilitate extinguishment. FF Annoreno remained on scene to assist with investigation.
- January 31 Tender 36 responded into Barrington/Countryside for a structure fire. The incident escalated to a 4<sup>th</sup> alarm due to lack of water. The Tender shuttled 22,000 gals of water to the scene over the course of 4 hours. Chief May was also dispatched and was assigned the Rehabilitation Division.
- January 31 Station 36 companies responded to a possible structure fire at 2100 Ela (south of Algonquin). Upon arrival they found a moderate amount of smoke coming from one of the home's chimneys. It was determined that the homeowner was using the fireplace to burn a Christmas tree. There was no fire extension.
