## **FIRE DEPARTMENT MONTHLY REPORT**

**June 2015**

This month's activities resulted in Station 36 responding to **95** calls for service; **51** incidents were for emergency medical and **44** incidents were suppression-related. Station 36 responded to **25** calls within our section of the Village of Inverness and **4** calls in the other side of Inverness. The District logged **8** calls within the Southeast Area and **17** incidents in all other contract areas for an overall total of **120** calls.

#### **06/10/15 15-00447 1275 Baldwin, VOP Structure Fire**

(Red Shift) Engine 36 and 701 responded to a high-rise apartment building in Palatine on a Box Alarm. Engine 36 assisted with evacuation of several disabled tenants from the upper floors of the building. D/C May (701) was assigned the Lobby Division to coordinate crew assignments to the fire floor.



**06/10/15 15-00449 Palatine & Chipping Camden, Auto Accident**

(Gold Shift) Engine 36 responded with Barrington/Countryside for an accident on Palatine Rd at Chipping Camden in South Barrington. The vehicle had left the road and ended up in a ravine, trapping the driver.
